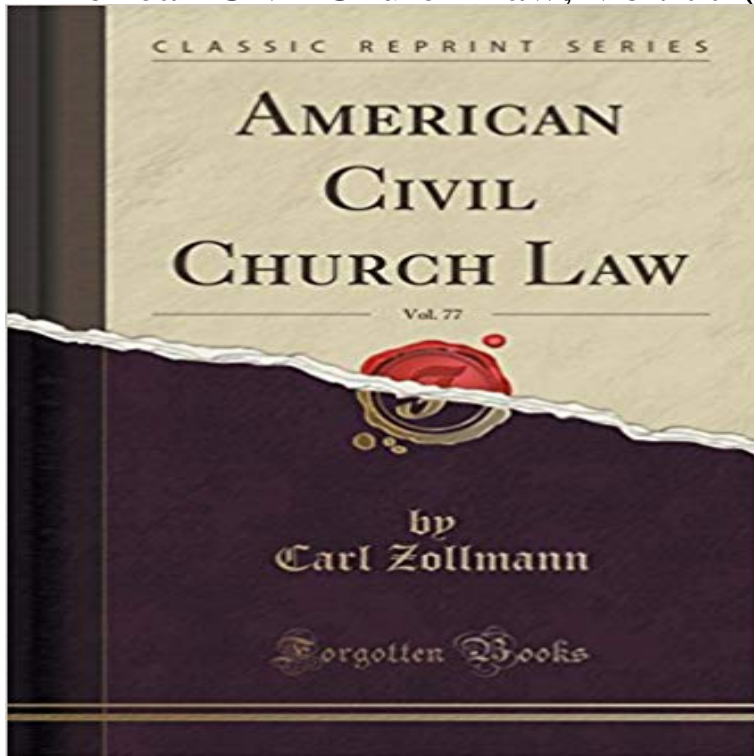

These relations do not rest on antagonism or indifference but on cordial cooperation. While the state by its legislative, judicial, and executive powers creates, guards, and enforces the civil, contract, and property rights of all the various denominations, these in turn, by their charitable, religious, and moral influences, save, protect, and preserve the state from an overgrowth of pauperism, delinquency, and crime. These mutually advantageous relations have grown out of the very life of the American people as a nation and have crystallized one of the fundamental principles of their political philosophy into concrete form.
