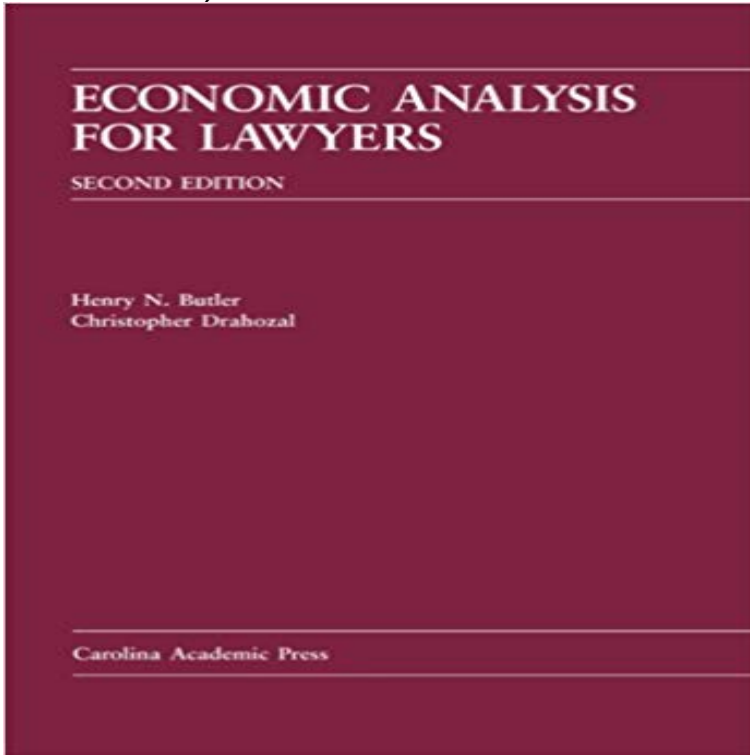


# Economic Analysis for Lawyers (Carolina Academic Press Law Casebook)
