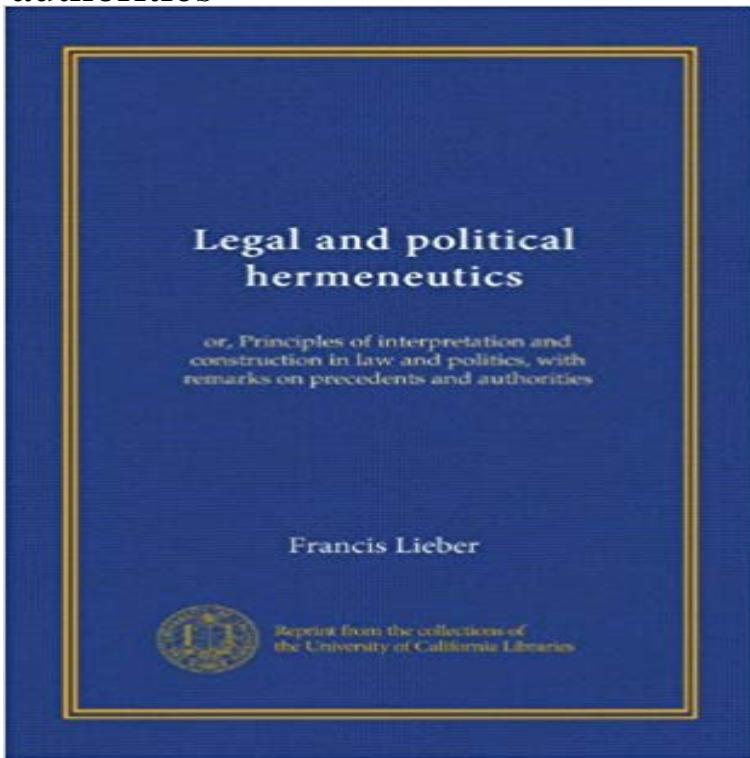


# Legal and political hermeneutics: or, Principles of interpretation and construction in law and politics, with remarks on precedents and authorities
