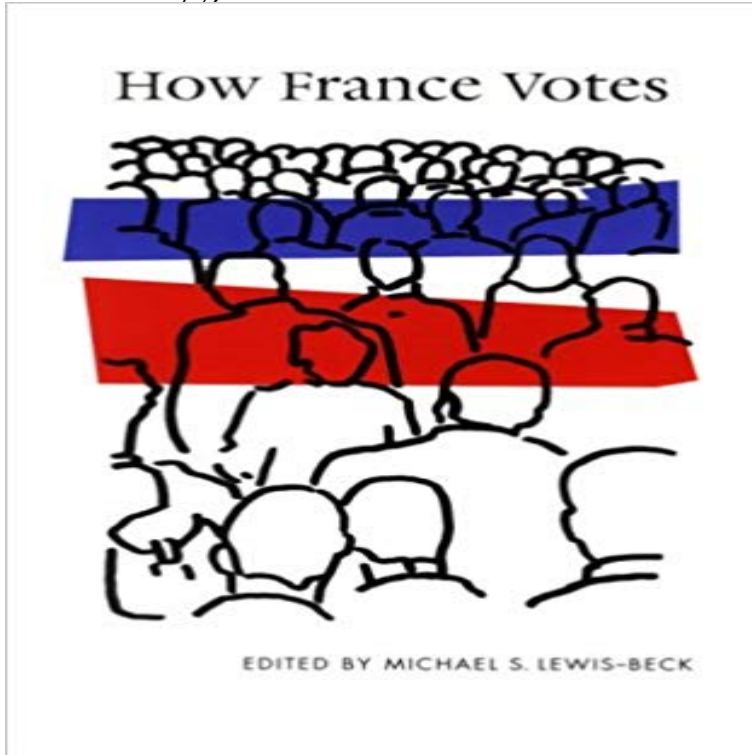


How France Votes (Comparative Politics & the International Political Economy,)
