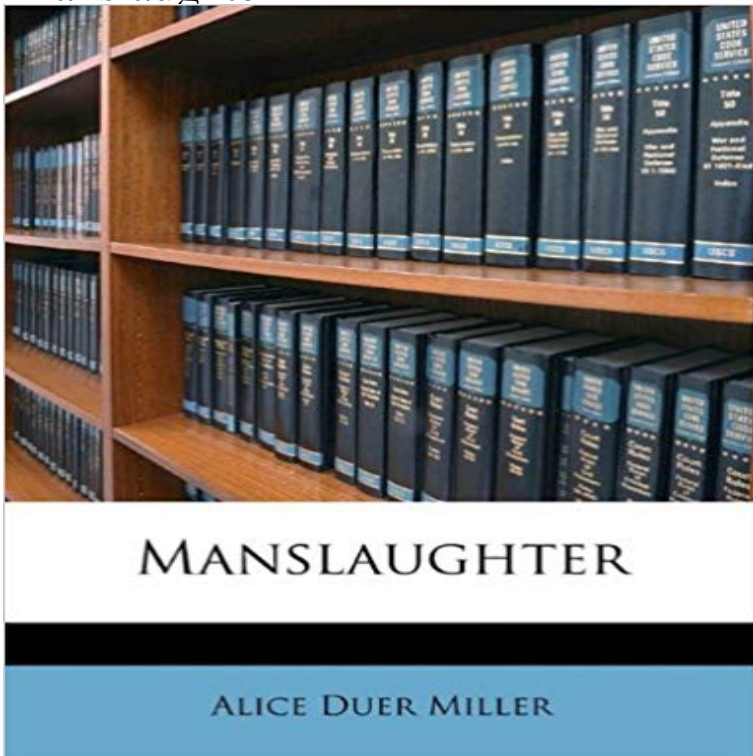


Manslaughter
