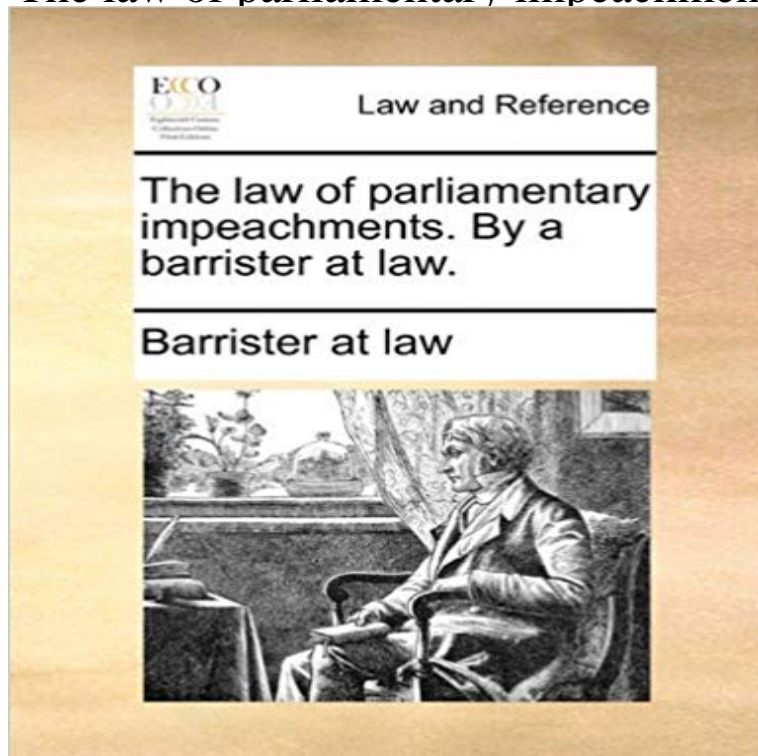


## The law of parliamentary impeachments. By a barrister at law.
