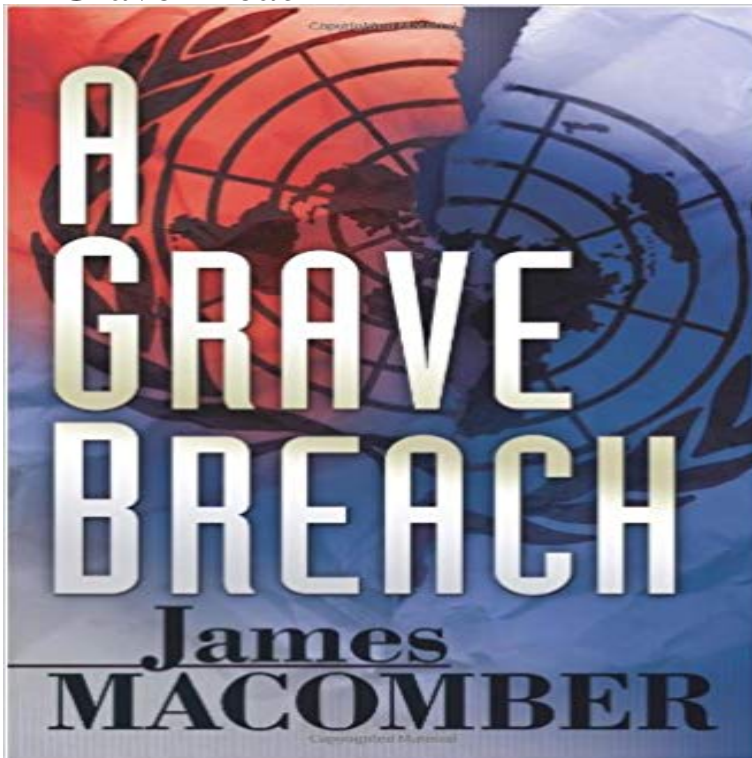


A Grave Breach
