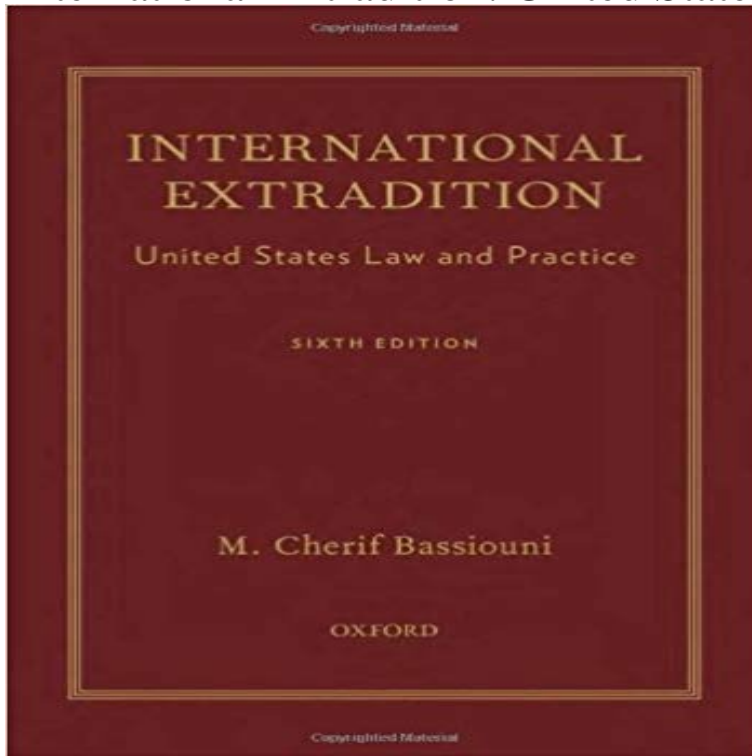


# International Extradition: United States Law and Practice
